SNOW REMOVAL SERVICE

Snow Removal Service will commence on November 1, 2016; and conclude April 15, 2017.
Snow plowing is to begin within a reasonable time after snow accumulation reaches a minimum of 2 inches (2.0").
Snow depths will be determined by the official report of the National Weather Service (248-620-2355).
Due to the times and amount of snow received, driveways, lots, and walkways may not be clear at all times of use.
Due to the variables of temperature changes, wind, snow drifts, compacting, piling, and etc. it is impossible to guarantee driveways, lots, and walkways to be cleared to bare pavement. Service includes return trip to clear snow from the end of the driveway after the streets have been cleared, this will be made the following day of the snowfall (no charge). It is the duty of the customer to afford access to the subject premises at all times and contractor shall not be responsible for delay or failure to perform plowing services when access is denied or unavailable. Snow Removal Service includes the first 12 visits; determined by the following: less than 4.0" = 1 visit; 4.0" or more but less than 8.0" = 2 visits; 8.0" or more but less than 12.0" = 3 visits; 12.0" or more but less than 16.0" = 4 visits; 16.0" or more but less than 20.0" = 5 visits; and extreme snowfalls 20.0" or more = 6 visits. If a return trip is provided to clear snow from around parked cars, provided that the car has been moved customers account will be assessed 1 additional visit charge. If we exceed 12 visits, it is agreed that customer will pay 10% of initial contract price per visit thereafter. In addition, excessive snow piles that require moving per customer request are subject to our current hourly labor rate (+) equipment rental fee if needed.

All prices are for straight driveway service only; circle driveway will not be serviced unless option is selected on contract.

Driveway markers will be installed by December 1, 2016. Throughout the winter, the markers may break or become lost in the snow; as a result, there may be some minor damage to the sod along the driveway edges, please notify us of this and we will schedule all grass and sprinkler repairs in the spring. Any other damages must be reported within 48 hours of snowfall. Failure to report damages constitutes a waiver and the contractor is released from liability.

HomeSlam Landscaping & Snow Removal, Inc. shall not be held responsible or liable for any accidents resulting in injuries due to slips/falls on customer's property due to weather conditions for anyone except employees of contractor.
No service will be provided without a signed contract and full seasonal payment.

Please note that all contracts can be terminated by either party with 7 days written notice.

Failure to make timely installments terminates the contract and relieves the contractor from any further liability.

Please note that if service is required on Dec. 25, 2016 our service may be slowed due to the holiday.
